The LGU-Cabanatuan City, through the SEF Fund FY 2023 intends to apply the sum of Eight Hundred Twenty-One Thousand Sixty-Five Pesos and 88/100 (P821,065.88) being the Approved Budget for the Contract (ABC) to payments under the contract for the Furnishing of Labor and Materials for the Installation of Feeder Wire @San Isidro Integrated School, Cabanatuan City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LGU-Cabanatuan City now invites bids for the above-mentioned project. Completion of the Works must be accomplished within Ten (10) Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

A complete set of Bidding Documents may be acquired by interested Bidders on 7 September, 2023 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P1,000.00). The Procuring Entity shall allow the bidder to present its proof of payment of the fees.
6. The LGU-Cabanatuan City will hold a Pre-Bid Conference<sup>1</sup> on 15 September, 2023 at 10:00 am at the Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 27 September, 2023 at 10:00 am. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on 27 September, 2023 at 10:00 am at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
